Happy Holidays to everyone! Great things have been going on in your Association this year to improve and advance the work of the IRTA. Our goal has been to better serve our members and promote our Association throughout the state's educational arena. Your officers and Executive Director have been very busy and I would like to review some of the highlights.

Probably the most visible change this year was the introduction of our new IRTA logo created by the IRTA Website Committee. The red, white, and blue insignia quickly catches one's attention and helps to brand our Association.

Last year the IRTA Strategic Planning Committee began discussing and working on ways to take our Association forward in the 21st century. Discussion and plans on revising present committees and the introduction of new committees are in the process. Also, ways of contacting and growing our membership have started to be implemented.

For our membership, a number of great new benefits have been added that include new travel discounts and senior-needs benefits. If you haven't tried out the Hotel Storm discount while traveling, you are missing out on great savings. Also, the savings on our AT&T and Verizon discount programs have been increased. A description of all of our benefits can be found on our webpage www.retiredteachers.org.

The Rules, Bylaws, and Credential Committee has taken upon itself to revisit and update the IRTA Bylaws. The plan for completion is June 2018. This is something that to our knowledge has not been done since our Association's beginning in 1950. This will greatly help to streamline the operations of the Association.

A new membership database program started years ago is now serving our local chapters, a new financial operational program recommended by the Association's auditor has been initiated, policy manuals have been reviewed and updated.

Another highly visible improvement has been the complete renovation of our website. It is now much more user-friendly to our membership and state committees. IRTA is now on Facebook and Twitter. Many helpful blogs for retired and active teachers are provided monthly and educational and informative webcasts are periodically presented. New and renewal memberships for both retired teachers and associates can now be submitted on the IRTA website. The recently updated Educator's Guide to Retiring With Purpose is available to active teachers online.

Our membership has been awakened to the influence of the American Legislative Exchange Council (ALEC) in our state legislature. If you missed out on the ALEC PowerPoint presentation at the Fall Workshop, be sure to ask your Area Directors for information. To be affective in talking to our local and state legislators, our membership needs to know and understand the influences that direct their decisions.

A final highlight is that the Foundation has given out \$10,000 in teacher grants across the state for the second year in a row. This is in addition to the \$20,000 in scholarships to college junior and seniors enrolled in education courses. Several

Executive Director's Message



Wow, what a Fall, the Cubs win the World Series, we have one of the warmest and driest Falls on record, a crazy election, and we had our biggest full moon we will see in many years. Hopefully these oddities will continue and our Indiana State Senators will have an epiphany and come to the realization that our retired educators and public employees need support and that they will see fit to

give a fiscally responsible COLA in this year's budget. We can only hope as we enter the "Season of Miracles".

The legislative Pension Management Oversight Committee (PMOC) finished up their summer meetings in October. Bills that will be coming forward from the committee will be an Indexed Cost of Living Adjustment (COLA) Bill sponsored by Rep. Carbaugh. This bill will give a 3% COLA to those that make the least and have been retired the longest, 2% COLA for those in the middle, and then a 1% COLA to those that have been retired less than 10 years. This bill only had two against it at PMOC, Senator Boots and Rep. Culver.

IRTF Active Teacher Grant Winners

This year was the second year of the Indiana Retired Teachers Foundation (IRTF) **Active Teacher Grants**. The applicants started submitting their grant proposals in August, following the guidelines set forth by IRTF (visit www.retiredteachers.org under the Foundation link to view the **Indiana Retired Teachers Foundation** Active Teacher Grant Guidelines and Application). There were 181 applications submitted by the September 30 deadline from active teachers across the state of Indiana. Each IRTA area could name up to two winners at \$500.00 each or could divide up the \$1,000.00 funds among several teachers.

The IRTF now announces 21 teachers across Indiana who have won an **Active Teacher Grant**. The winners are listed below by areas. More information can be found by contacting the office at (888) 454-9333 or visiting our website at www.retiredteachers.org.

We also believe that Rep. Karickhoff will bring another COLA bill forward asking for a straight 2% COLA for everyone. We will support both bills and see which comes out of the House committees.

Rep. Burton is sponsoring a "13th Check Bill" that will have an increase of \$50 for those making less than \$500 in their monthly pension check and a \$25 increase for those making more than \$500 per month in their pension. This is the first increase since the inception of the "13th check" concept in 1993.

We were hoping that the \$50 increase would be for anyone making less than a \$1,000 per month and \$25 more for anyone making more than \$1,000 per month. We will see if any work can be done on it as it starts through the committee process.

Rep. Carbaugh is expected to bring a Defined Contribution (DC) bill forward that is improved over last year's DC bill, but we still cannot support it as a retirement vehicle for our future teachers. We also expect the Rep. Culver will bring a bill forward calling for Public Employees to default into a DC plan if they do not choose an option. We will oppose this bill if it is brought forward. Our belief is if they get this in the Public Employee Pensions, the next target will be the Retired Teacher's Pension plan for future educators.

There were a few changes in the legislature after the election and the committees and leadership for the committees have seen a little change. The Labor Committee in the House has new leadership. Representative VanNatter from Kokomo area will now be chairman. Representative Gutwein had been the previous chairman. This year's long budget session kicks-off on January 3rd/4th and will go through April 29th. The COLA and "13th Check" will no doubt hang in the balance until the last couple of days of session since they are both tied to the budget.

We met with Rep. Brown, Chairman of the House Ways and Means Committee, in the early Fall. We felt we had his support and that he will look for ways to fund the COLA and "13th Check" bills. This is critical if the bills are to receive a hearing in the Senate. We will be informing you through letters, email, Facebook, Twitter and our podcast on legislative information throughout this session. Your voice will once again be very critical in any chances we have to receive a COLA and/or "13th Check".

The Indiana Public Retirement System (INPRS) should have notified you if you have money in your Annuity Savings Account (ASA) and some of your money is in the Guaranteed Fund. It will be switched to the Stable Value Fund on December 31st. The Guaranteed Fund is being closed out and the Stable Value Fund is the replacement fund. You may choose

other funds prior to December 31st to place your money in that INPRS offers. You may contact INPRS at (888)-286-3544 if you have further questions.

Dennis's article highlights many projects and activities that the IRTA Board and office staff are working on as we continue to move forward and meet the needs of our members. Please continue to use our website (www.retiredteachers.org) as a resource for information and friend, like, and share information off our Facebook page.

A new initiative that we will be starting in January is a weekly podcast called Indiana EdCAST that you may download at www. retiredteachers.org/podcast. For those that are not familiar with podcasts, they are very similar to a radio talk show segment. The first few months our podcasts will highlight Statehouse activities and legislation with myself and our lobbyist Steve Beebe providing updates. We will also inform you with what is new at IRTA along with having other guests on the podcasts to discuss educational issues, programs, information and other topics that we believe our members and listeners around the state of Indiana will find interesting.

We hope you will be able to tune in to our weekly podcasts. The podcasts will be a mix of live shows and taped shows depending on schedules of our guests. Our first episode of Indiana EdCAST will air at 11:00 AM on Friday, January 6th and then every Friday thereafter at 11:00.
