



## **Parent Representative Family Partnership Meeting on Monday 7.2.18**

**Meeting was held at JCCC Lincoln from 12:00 pm to 1:00 pm**

### **WELCOME—LaShawnda Pearson, Center Director JCCC Main**

- Began by welcoming those in attendance

### **CURRENT CENTER HAPPENINGS—LaShawnda Pearson, Center Director JCCC Main**

- Discussed the upcoming Transition Orientation meetings taking place the week of July 23<sup>rd</sup> to 27<sup>th</sup>.
- Email will be sent out on 7.2.18 with Sign Up Genius links, which correspond to the classroom your child is transitioning into in August.
- Highlighted the new, updated website and the location of many important documents under the “For Our Parents” heading.
- Cow Appreciation Day is July 10<sup>th</sup>
  - With the absence of Camp this year, JCCC will not be hosting a parade at Chick-fil-A’s main building.
  - We will have the Chick-fil-A Cow at JCCC in the morning and individual classrooms may be planning special activities.

### **MONDAY MEMO FEEDBACK—LaShawnda Pearson, Center Director JCCC Main**

### **MY BRIGHTDAY ROLLOUT—LaShawnda Pearson, Center Director JCCC Main**

- Reviewed the logistics of My Bright Day and distributed registration instructions.
- Parent Representatives from each classroom will participate in a trial run of My Bright Day beginning July 9<sup>th</sup>.
- Parent Representatives who participate in the trial run will give feedback on areas of improvement.
- My Bright Day will roll out to all families beginning July 16<sup>th</sup>.

### **OPEN DISCUSSION—LaShawnda Pearson, Center Director JCCC Main**

- Parent present asked if there were any new construction/parking updates.

### **Question and Answer**

**Will information from Transition Orientation meetings be available to those families who may be out of town?** Information will be made available to those who are out of town by email through your child's Education Coordinator.

**Can the Illness Policy be uploaded to the website under the "For Our Parents" tab?** LaShawnda responded by saying that she will need to double check if the policy can be uploaded to a public website. If not, the policy will be sent out again via email.

**Will My Bright Day be the only portal for classroom information and documents?** My Bright Day will only replace the hard copy Daily Experience sheets and streamline Teaching Strategies and parent/teacher communication. While we will be using the iPads for tracking, we will still be utilizing hard copy tracking sheets and other hard copy paperwork, such as Occurrence Reports, which are required by licensing.

**When will Pick My Kid be launched?** We are still in communication with the representative from Pick My Kid. We will update families when we have new information.

**Will updated Teacher Placements be available for the upcoming Transition Orientation meetings?** We have hired new teachers and will update families on placements when they have completed their training. We hope to have this information available at Transition Orientation meetings but may still be recruiting.
