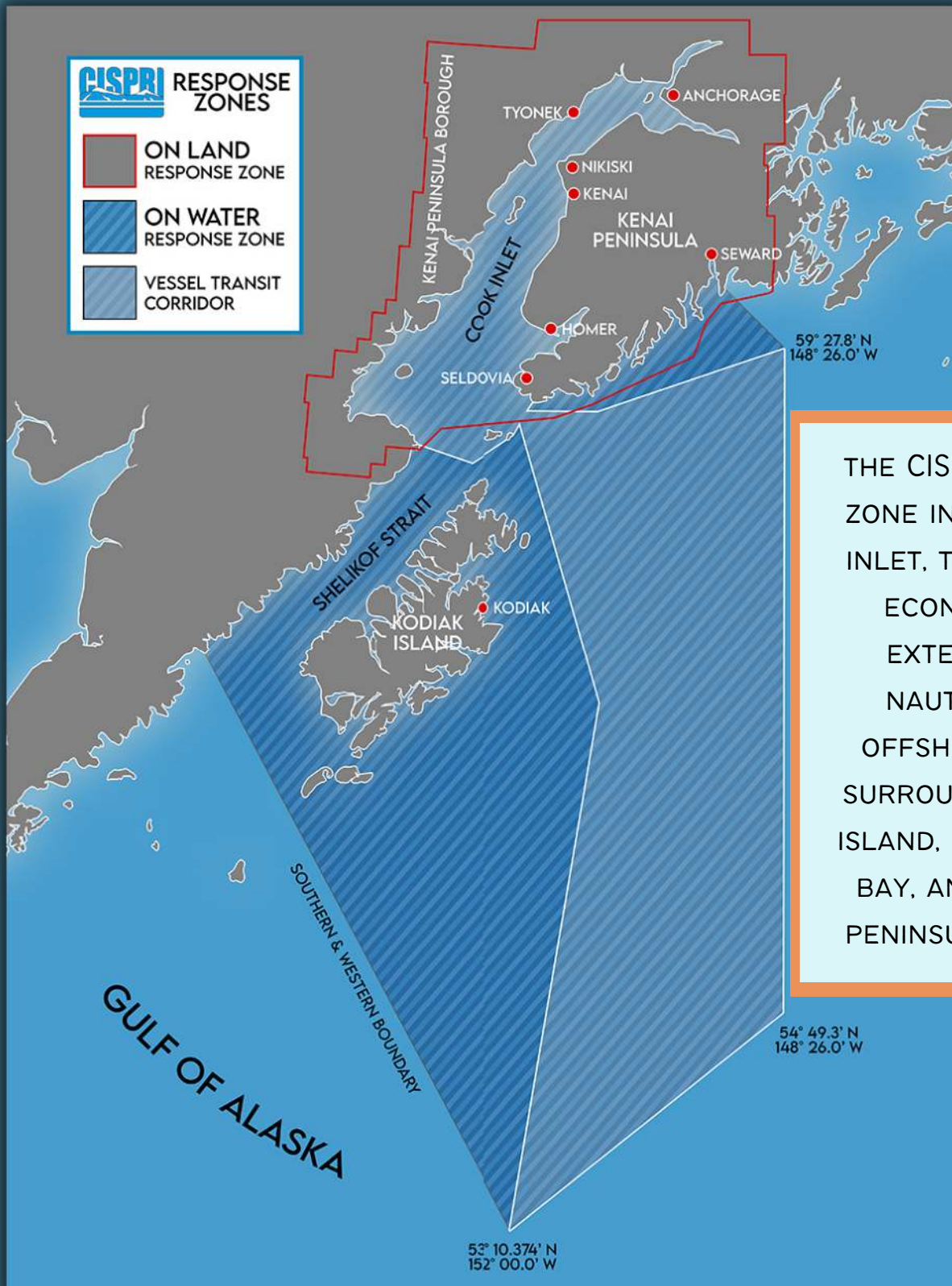

# RESPONSE ZONE



THE CISPRI RESPONSE ZONE INCLUDES COOK INLET, THE EXCLUSIVE ECONOMIC ZONE EXTENDING 200 NAUTICAL MILES OFFSHORE, WATERS SURROUNDING KODIAK ISLAND, RESURRECTION BAY, AND THE KENAI PENINSULA BOROUGH.





# TRAINING

- » CISPRI PLANS AND PARTICIPATES IN WEEKLY TRAINING ACTIVITIES INTENDED TO CONTINUALLY IMPROVE ON THE SAFETY, SKILL SET AND KNOWLEDGE BASE OF OUR RESPONDERS AND MEMBER COMPANY PERSONNEL.
- » TRAINING ACTIVITIES ARE DETERMINED BASED ON MEMBER REGULATORY REQUIREMENTS AND FURTHER DEVELOPMENT OF RESPONSE PERSONNEL.
- » UNDERLYING ALL TRAINING DEVELOPMENT AT CISPRI IS THE COMMITMENT TO INSTILL AND GROW THE CISPRI SAFETY CULTURE, WHICH PUTS A FOCUS ON EFFECTIVE PRE-JOB SAFETY PLANNING AND CREW COMMUNICATIONS.



## DRILLS

- » CONDUCT AND PARTICIPATE IN RIGOROUS DRILL EXERCISE PROGRAMS IN WHICH MEMBER COMPANIES, GOVERNMENT AGENCIES, CISPRI PERSONNEL AND CONTRACTORS ACTIVELY PARTICIPATE IN SIMULATED OIL SPILLS.
- » THESE EXERCISES AND SCENARIOS ARE DESIGNED TO BE REALISTIC, INVOLVING 'REAL TIME' ENVIRONMENTAL CONDITIONS, SIMULATED AND/OR PHYSICAL DEPLOYMENT OF RESPONSE RESOURCES, AND IN-DEPTH PLANNING BY THE INCIDENT MANAGEMENT TEAM.

# TEST TANK

**THE ONLY ONE OF ITS KIND IN ALASKA!**



- » PURPOSE BUILT TO TEST OIL SPILL RESPONSE EQUIPMENT AND PROVIDE TRAINING ON EQUIPMENT USE, THE CISPRI TEST TANK IS A COVERED 15,000-GALLON TANK MEASURING 25' X 25' X 4' WITH ITS OWN OIL DISTRIBUTION AND MEASUREMENT SYSTEM.
- » DESIGNED TO FACILITATE THE ASTM F2709-19 STANDARD TEST METHOD FOR DETERMINING A MEASURED NAMEPLATE RECOVERY RATE OF OIL SKIMMER SYSTEMS. A MIXED WATER COMBINATION IS USED TO MIMIC THE COOK INLET ENVIRONMENT AND TRUE ALASKA CONDITIONS.
- » THE CISPRI TEST TANK CAN BE MADE AVAILABLE FOR TESTING AND TRAINING SUPPORT. IF YOU HAVE A NEED OR DESIRE TO USE THE TANK, PLEASE CONTACT CISPRI AT 907-776-5129.

# PROTECTING ALASKA

## CISPRI HAS ESTABLISHED AN EXTENSIVE SPILL RESPONSE PROGRAM FOR COOK INLET AND THE CISPRI RESPONSE ZONE:

- PURCHASED SPECIALIZED SPILL RESPONSE EQUIPMENT SELECTED TO MEET THE UNIQUE ENVIRONMENTAL CONDITIONS OF COOK INLET.
  - THIS RESPONSE EQUIPMENT IS STAGED THROUGHOUT THE CISPRI RESPONSE ZONE BASED UPON RELATIVE RISKS. INFORMATION ON RESPONSE EQUIPMENT CAN BE FOUND IN THE CTM.
- DEVELOPED THE CISPRI TECHNICAL MANUAL (CTM) TO DETAIL THE SPECIFIC TACTICS AND RESPONSE EFFORTS REQUIRED TO SUCCESSFULLY RESPOND TO AND REMEDIATE OIL SPILLS IN COOK INLET.
- RETAINED IN-STATE CONTRACTORS TO PROVIDE SHORT NOTICE RESPONSE TEAMS (SNRT), WITH HAZWOPER AND SPILL RESPONSE TRAINING, TO RESPOND TO THE DESIGNATED LOCATION WITHIN 4 HOURS. ADDITIONAL PERSONNEL ARE AVAILABLE FROM THESE SOURCES IF NEEDED.
- MAINTAIN CONTRACTS WITH ESTABLISHED WILDLIFE RESPONSE ORGANIZATIONS TO RESPOND TO AND REHABILITATE OIL IMPACTED BIRDS AND MARINE MAMMALS.
- ESTABLISHED CONTRACTS WITH NUMEROUS FISHING AND COMMERCIAL VESSELS AND ADDITIONAL SPECIALISTS TO ASSIST AND SUPPLEMENT CISPRI EFFORTS AS NECESSARY.
- REGULARLY PARTICIPATES IN MEMBER COMPANY DRILLS AND FIELD DEPLOYMENTS.

# WILDLIFE RESPONSE



CISPRI MAINTAINS WILDLIFE RESPONSE CONTRACTS WITH BOTH THE ALASKA SEALIFE CENTER (ASLC) AND INTERNATIONAL BIRD RESCUE (IBR) FOR RESPONSE & REHABILITATION SERVICES OF OIL IMPACTED WILDLIFE.

CISPRI OWNS AND MAINTAINS THE SEA OTTER REHABILITATION CENTER (SORC), LOCATED IN SELDOVIA, AK, FOR EMERGENCY RESPONSE OF OIL IMPACTED OTTERS AND/OR SMALLER PINNIPEDS.

ADDITIONALLY, CISPRI OCCASIONALLY WORKS WILDLIFE RESPONSE EXERCISES INTO YEARLY TRAINING ACTIVITIES, TO INCLUDE BUT NOT LIMITED TO:

- USDA APHIS WILDLIFE DETERRENCE FOR OIL SPILL RESPONSE
- MARINE MAMMAL CAPTURE & HANDLING - PROVIDED BY ASLC
- WILDLIFE FIRST RESPONDER TRAINING - PROVIDED BY HILCORP
- AVIAN CAPTURE & STABILIZATION - PROVIDED BY IBR
- SORC FAMILIARIZATION TRAINING
- BEAR GUARD TRAINING





- IBR IS AN INTERNATIONALLY RECOGNIZED ORGANIZATION AND HAS RESPONDED TO OIL IMPACTED WILDLIFE AROUND THE WORLD. IBR IS OPERATIONAL YEAR-ROUND, PROVIDING CRITICAL CARE TO WILDLIFE BEYOND OILED WILDLIFE RESPONSE.
- IBR MAINTAINS AN OILED WILDLIFE RESPONSE TEAM AND PROVIDES SUPPORT THROUGH AN EXPERIENCED TEAM OF WILDLIFE EXPERTS, VETERINARIANS, REHABILITATORS, EMERGENCY MANAGERS, AND A TURN-KEY RESPONSE CENTER LOCATED IN ANCHORAGE, AK.



- LOCATED IN SEWARD, AK, THE ASLC IS THE ONLY FACILITY IN ALASKA THAT COMBINES A PUBLIC AQUARIUM WITH MARINE RESEARCH, EDUCATION, AND WILDLIFE RESPONSE. THE ASLC IS A NONPROFIT ORGANIZATION AND THE ONLY PERMANENT MARINE MAMMAL RESCUE AND REHABILITATION FACILITY IN THE STATE.
- THE ASLC OILED WILDLIFE RESPONSE TEAM PROVIDES SUPPORT THROUGH A SPECIALIZED TEAM OF VETERINARY PROFESSIONALS, WILDLIFE REHABILITATORS, AND ANIMAL CARE STAFF, AS WELL AS AN ON-SITE REHABILITATION FACILITY, MOBILE RESPONSE EQUIPMENT AND SUPPLIES.



CISPRI OWNS AND MAINTAINS THE SEA OTTER REHABILITATION CENTER (SORC) LOCATED IN SELDOVIA, AK.

- THE SORC INCLUDES PURPOSE BUILT CONEX UNITS FOR OILED WILDLIFE RESPONSE.
- FEATURES A VARIETY OF WET AND DRY HOLDING OPTIONS, AND PRE-RELEASE PENS.
- WHILE THE SORC WAS DESIGNED WITH SEA OTTERS IN MIND, IT IS A FLEXIBLE SPACE AND CAN BE USED TO TREAT SMALLER PINNIPEDS, IF NEEDED.
- THE ASLC IS CONTRACTED TO STAFF THE SORC FOR WILDLIFE RESPONSE.

- SECURED SPECIALIZED EQUIPMENT TO CONDUCT ALTERNATIVE RESPONSE MEASURES, INCLUDING APPLICATION OF OIL DISPERSANTS AND IN-SITU BURNING OPERATIONS
- ESTABLISHED A VAST COMMUNICATIONS NETWORK THROUGHOUT COOK INLET

- DEPLOY EXTENSIVE INVENTORY OF RESPONSE EQUIPMENT WHICH IS MAINTAINED AND OPERATED BY A TEAM OF PROFESSIONAL CISPRI EMPLOYEES.
- STRIVE TO CONTINUOUSLY IMPROVE SPILL RESPONSE PREPAREDNESS, CAPABILITY, AND CONSISTENCY.
- SATISFY REQUIREMENTS OF FEDERAL, STATE, AND LOCAL GOVERNMENT STATUTES AND REGULATIONS (INCLUDING THE OIL POLLUTION ACT OF 1990) ON BEHALF OF OUR MEMBER'S RESPECTIVE REGULATORY RESPONSE PLANS.
