

TRACK PRIVATE GROUP ACKNOWLEDGEMENT

The information attached explains the mandated protocols and requirements to be handled and shared with your participants by you, the representative, prior to arriving for your track rental dates. As stated, all protocols must be followed, without exception. The information provided is as follows:

- Clearly defined protocols to be shared with all participants and practiced while onsite. No exceptions.
- A registration log is to be completed and submitted prior to arrival to the Track Operations Supervisor. The log will be used for checking in all organizers, participants and, if required, vendors to the paddock area.
- The "Communicable Disease Release Waiver" and "Release and Waiver of Liability" are to be completed and signed by all participants. This is a requirement of our insurance carrier.
- **Registration logs are required to be completed by the representative of the rental. The logs are due to the Track Operations Supervisor ten (10) days prior to your scheduled track rental. All pertinent information is required for all participants and attendees. The log will be used as one of the protocols in granting access to the secured paddock area. Information to include full name, residence address, cell number and vehicle license plate number. PLEASE NOTE WE WILL NEED THIS INFORMATION AND YOU WILL NOT BE ALLOWED ACCESS TO THE TRACK WITHOUT US HAVING YOU ON OUR LIST.**
- Information will be verified based on log sheet submitted by the organizer and picture I.D. driver's license. The I.D. verification will be required of participant's guests as well. Registration check-in will be at the entry to the paddock.
- Participants are to provide their own face masks and are required to wear it when outside of a vehicle. Gloves are recommended.
- **Each car entered will be allowed 2 people into the paddock. Driver + 1. If you are working with a team hauling cars the team may have a total of the number of cars + 1. Example: 200 cars entered = 400 people allowed. All Haulers must have the race car numbers listed. This is a 1 car trailer or a multi car stacker.**
- Temperatures will be checked with No Touch Thermometers upon entry to the paddock. Those recording a temperature of 100.4°F or higher will be turned away. Any individual who is not feeling well, experiencing a cough or fever, are requested to stay home.
- No social grouping is allowed while on track or pit lane.
- No more than six (6) people will be allowed in any one area and 6' distancing must be adhered to. Face masks are to be worn when outside of vehicle.
- **Paddock layout must demonstrate 8' of separation between vehicles. We will be letting folks into paddock area and spacing accordingly. This could take some time.**
- If used by renter, pit lane layout must demonstrate 8' of separation between vehicles.
- Individual vehicle track time will be determined by representative. Only one person allowed in the vehicle at a time. Once driver is in vehicle, he/she must remain until returning to the paddock. Needed services, such as fuel, vehicle breakdown or track incident would be an allowed exception with 6' spacing attempted.
- **All onsite participants, guests, instructors, vendors, etc., are required to remain in the paddock. Anyone that leaves will be required to fulfill all established protocols to re-enter the paddock.**

- Rentals that are driving schools, instruction will be required to take place outside, following the 6' spacing mandate or by means of electronic services. No classroom instruction will be allowed.
- All meetings will be held outside, following the 6' spacing mandate.
- Paddock will be monitored by onsite paddock personnel and Security. The above requirements are to be followed without exception. Anyone found in violation will be asked to leave the paddock and no monetary reimbursement will be given.
- **Please discourage social media or promotional postings. Our continued ability to operate track activities can be swayed by public opinion. DO NOT POST ANY PHOTOS TO SOCIAL MEDIA WHAT YOU POST MAY END UP ON THE EVENING NEWS!**
- Photographers/media may be allowed by Track Operations Supervisor on a case by case basis.
- **No pets allowed in the paddock. This includes animals confined to kennels or vehicles.**
- Garages may be utilized; all doors are to remain open and only one car per bay, alternating when possible..
- Representative will assign garages and paddock locations prior to arrival. A map is included in your packet.
- Participants must remain in their assigned paddock or garage spaces when not on track, unless utilizing facility services, restrooms, cafe, or fuel pumps.
- As a reminder, helmets must be worn at all times when on track. Face masks must be worn when interacting with staff or fellow participants.
- **There is no camping in the campgrounds, and the showers will not be available.**
