Thank you for your commitment to instruct at our Windy City BMW High Performance Driving Experience (HPDE) at Putnam Park on Saturday and Sunday, September 21 & 22, 2019. Instructor day is September 20th.

See the driver letter –attached- for the rest of the information on the experience, times, maps, sample waiver, Medical Form, car insurance option info, etc.

NEW PROCEDURE FOR INSTRUCTOR WORK LOADS

- ➤ We have a scheduling break between the Red Novice and Yellow Intermediate run groups so you won't have back-to-back drivers.
- ➤ A fee for Friday still applies for all instructors and invited Solo Group drivers.
- ➤ Red and yellow groups will have assigned instructors. Green group will be able to choose an instructor, if they wish, from a separate instructor pool.
- Instructors are no longer required to ride with their driver in the last session of the day.

Special Run Group information:

- 1. There will be a Solo run group. Solo run group drivers are highly experienced HPDE participants. Eligibility for this run group will be decided by the DEC. The Solo run group will run in their own group and also be allowed to run with the instructor group. Instructors can drive in the Solo group.
- 2. Solo participants will have the opportunity to select an instructor for a session. This gives the experienced HPDE participant the opportunity to continue learning.

Instructor / Driver pairing assignments will be sent via email before the event. Please contact your driver(s) ahead of time to discuss their goals, skill level, car modifications, previous track-driving experience, etc.

Technical Inspection: The form is attached. You must present the signed/certified tech inspection sheet at registration on the day of the event. You must sign the form as participant.

Your car must pass inspection before coming to the event. There will be NO onsite inspections. There will be NO Chapter pre-tech event. Your vehicle's status is subject to review by the event Tech Steward if questionable conditions are noted. No refunds are given if unsafe vehicles are brought to the event.

The technical inspection is for your safety and the safety of others on the track with you. As this is a BMW CCA national requirement THERE ARE NO EXCEPTIONS TO THIS RULE.

Friday Instructor Day: The instructors' track time will be <u>Friday</u>, September 20th from 9:00 to 5:00. If you cancel more than 24 hours before the Friday Instructor Day, you will receive a 90% refund for that day. Otherwise there will be no refund. No guests can take rides on Friday.

There will be designated instructor track sessions on Saturday and Sunday, plus you can drive with the Green Group. No racing will be allowed. This applies for the whole weekend.

Car: It must be in the car you registered in and must be quiet. If you have a change in cars after registering, notify Randy Everson. Equal restraints are required.

Helmets: Helmets must be SNELL or SFI 2010 or newer. Helmets have to be checked at the track registration if you don't already have a current Windy City BMW inspection sticker (yellow or green).

Parking at Putnam: parking is on the large gravel and paved areas south of the lawn. Twenty garages are available for rent on a first-come-first-served basis

Saturday Morning: The track opens at 7:00 AM. Registration from 7:00 till 7:30 in the covered shed between the tower and the concession stand. Mandatory Instructors' meeting at 8:00 in the pit area.

Sunday Morning: The track opens at 7:00 AM. Registration from 7:00 till 7:30 in the covered shed between the tower and the concession stand. Mandatory Instructors' meeting at 8:30 in the pit area.

You will be doing a simple paddock check of your driver's car before the first time out on Saturday morning. You will get a short list of things to check in your track packet. This list is for your reference, not to be handed in. Please do this same check on Sunday if you have a Sunday-only driver. If you find any safety issues, let an event Chairperson know.

Miscellaneous

You must have a communicator.

All instructors must have a full operator's license that is not suspended or revoked. Equal restraints are needed. If you have a harness then your passenger needs a harness.

Cars must have mufflers in working order to run.

If you cause property damage at the track, you are responsible for the repair cost.

Driver Evaluation Form: One is enclosed to review. Refer to it as you work with your drivers to be sure all points are covered in your instruction. These are the areas of skills we most want to teach. We recommend that after your drivers' last track time you discuss their progress (or lack thereof) during the HPDE. The Committee reviews each evaluation to be able to place the driver in the appropriate run group at their next HPDE. Please let our Chief Instructor know if you instruct a driver who you feel has both the skills and the interest in becoming an instructor. They could be invited to attend a future Instructor Training School to keep our instructor base growing.

We encourage you to maximize your in car instruction time with Red & Yellow drivers. You must also be in the car with Red (Novice) drivers on Saturday & Sunday mornings. If you do release any of your drivers for some solo track time, a sticker must be placed on the windshield by someone in the pit lane. You should continue to observe the progress of your released driver – the hillside on the south side of the pit area has views of almost the entire track.

Important points:

- * Be prepared to teach from the Windy City BMW Drivers Manual (you can download it at http://windycitybmw.com/photo.aspx?moid=15861) and the hand out below in this letter.
- * Keep a safe distance from the car in front of you except to pass.
- * If you or your driver has a 360 degree or more spin or four wheels off the track, you <u>must</u> come into the pit area to be checked.
- * Racing will NOT be tolerated. ANYONE ENGAGED IN RACING WILL BE EXPELLED, NO EXCEPTIONS, NO REFUNDS.

NO CONVERTIBLES WILL BE ALLOWED ON THE TRACK without a hardtop and SCCA type roll bar/cage

Gasoline & Air: Air and fuel are available at the track (expensive) or 5 miles away at normal pump prices.

Concession Stand: The concession stand will be open each day. The food is good. Your schedule has rest periods to allow time for you to eat.
