

**OFFICIAL MINUTES

BOARD of TRUSTEES  
MARCH 28, 2024**

Trustees Present: Christy Hart, James Lieb, John Lieb, Jason Varnon

Trustees Absent: Jerry Crowl, Justin Lane, Wirt Davis

Administration Present: Superintendent Scott Burrow, Business Manager Laurie Green, and Principal Jordan Hicks.

Art teacher Cindy Lieb and students Victoria, Natalie, Reggie, Ulysses, and Noah were also present.

A quorum was established, and President James Lieb called the meeting to order at 7:01 p.m.

No one was present for Public Comments/Audience Participation.

John Lieb moved that we approve both logos that the art class developed for Pringle Morse CISD. Christy Hart seconded the motion, which carried 4-0.

John Lieb motioned to approve the February 15, 2023, board meeting minutes. Jason Varnon seconded the motion, and it carried 4-0.

Business Manager Laurie Green presented the financial reports, including budget reports, cash positions, monthly expenditures, and preliminary values for Hansford County. (See Attachment).

There were no student transfers.

Jason Varnon motioned to approve a waiver for staff development. John Lieb seconded the motion, which carried 4-0.

Jason Varnon moved to approve the amended Districts of Innovation Plan. John Lieb seconded the motion, and it carried 4-0.

Jason Varnon motioned to approve the sale or disposal of buses from the fleet at Superintendent Burrow's discretion. John Lieb seconded the motion, which carried 4-0.

Superintendent Burrow and the Trustees discussed fencing proposals and Guardian training.

The Board of Trustees convened in closed session on March 28, 2024, at 8:35 p.m. in accordance with the Texas Open Meetings Act and ended its closed session at 8:47 p.m.



John Lieb, seconded by Jason Varnon, moved to extend the recommended one-year teacher professional contracts. The motion carried 4-0. (See Attachment).

Burrow reported that he posted the Pre-K and JH social studies positions.

John Lieb motioned to approve the resignation of Cindy Lieb, who will retire at the end of the school year. Jason Varnon seconded the motion, which carried 4-0.

Trustees set April 18, 2024, at 7:00 p.m. as the next board meeting.

Principal Hicks presented the activity report.

Superintendent Burrow reported:

Enrollment is at 119.

Buses are running with some repairs.

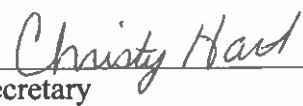
Burrow has posted proposal letters for fencing and solicited proposals from 3 vendors.
