**Registration Fee** means the registration fee as collected at registration via the online registration form.

**Venue** means the venue at which the Event is held

## APPLICATION & ACKNOWLEDGEMENT

### 1. AGREEMENT

- 1.1. CANSO b.v., trading as Airspace World, reserves the right to amend any and all Attendee Terms and Conditions at any time without notice to you. Your acceptance of this document constitutes that you accept these changes. Alterations will become effective at the time of publishing, and we suggest that you review these Terms and Conditions periodically.
- 1.2. CANSO b.v. reserves the right to cancel, change the date to any date within 12 months of the published Start Date, the format or relocate the Event at any time prior to the Event Date. CANSO b.v. bears no responsibility for any cost that a registrant may incur should this happen.
- 1.3. CANSO b.v. events are all staged as business to business events specifically for our community of Air Traffic Management (ATM) professionals across the globe. With this aim we incorporate a review of all attendees at the point of registration to ensure that they meet the criteria that is set out at each event. This aim is focused on meeting our sponsors and exhibitors ROI from their investment in our event and the value of the event to our professional community.

- 1.6. CANSO b.v. claims the right to reject any registration. If this happens, a full refund will be issued.
- 1.7. By attending the Event, visitors permit the organisers/approved third parties to use any footage taken. No person under the age of 18 years, including children of the exhibitors, will be admitted during any period of the event.
- 1.8. Your pass or pass code is personal to you. Sale of Event passes other than directly from CANSO b.v. is strictly prohibited. If an invitation code or link was given to you by an exhibitor, sponsor, advertiser, or other party who properly acquired the pass from CANSO b.v. (the "Pass Provider"), that code is personal to you, and cannot be sold, gifted, published, or otherwise transferred without express permission of CANSO b.v. You agree you will not sell your pass, purchase a pass from any person or entity other than CANSO b.v., publish/distribute any code such that others may use it without appropriate authorisation, or in any way work to facilitate access (including Your own) to the Event by unauthorised means.
- 1.9. By registering using a pass provided by the Pass Provider, you consent to the disclosure of your personal data to such Pass Provider, including your name, email address, company, and job title. If you wish to exercise any data protection rights with regard to how a Pass Provider processes or uses Your personal data, you must do so directly with such Pass Provider.
- 1.10. Registration for an Event must be made through an online registration form and be submitted to the Organiser
- 1.11. The registration will constitute the Delegate's commitment of participation and acknowledgement of these Terms and Conditions. The registration shall not be deemed to be accepted until approved in writing by the Organiser. The Organiser reserves the right to accept or reject registrations without giving any reason.
2. ATTENDANCE AND SECURITY
  - 2.1. The rights and privileges granted to Delegates are limited to attendance of the Event.
  - 2.2. Only Delegates who have received a written confirmation shall be guaranteed entrance to the event. We cannot be held responsible for the non-arrival of the registration information. ### 3. LEGAL

- 3.1. The relationship between CANSO b.v. and the Delegate will be exclusively governed and construed in accordance with the laws of The Netherlands without giving effect to any principles of conflicts of law. Any dispute regarding the interpretation or application of the present terms and conditions that cannot be resolved amicably between the parties shall be subject to the exclusive competence of the Dutch jurisdiction

### 4. PAYMENT

- 4.1. Selected Delegates may register free of charge; however, the registration shall not be deemed to be accepted until approved in writing by the Organiser.
- 4.2. Paid registrations must be received by credit card, in Euros and using the online registration form
- 4.3. Unused paid tickets/passes will be forfeited and are not transferable to another event.

### 5. CANCELLATION POLICY

- 5.1. Cancellation by the Organiser - In the event of a cancellation by the organiser, the Delegate shall be entitled to the reimbursement of any payment made to the Organiser. In the event of a postponement or relocation, the Delegate is entitled to recover any payment already made to the Organiser in case it decides to cancel its participation. Neither the Organiser nor its employees, local managers or agents shall have any liability to the Delegate in case the Event is cancelled, postponed or relocated due to circumstances outside the Organiser's control (Force Majeure as defined under art. 6.1)
- 5.2. Cancellation by the Delegate - The following cancellation policy applies to all Delegates. All cancellations must be sent in writing to the Organiser at [registration@airspaceworld.com](mailto:registration@airspaceworld.com). The indicated cancellation periods refer to the time prior to the first day of the event in question. Delegates wishing to cancel must give 1 months' notice. After this deadline, no refunds will be permitted.
- 5.3. Requests for substitution of a registered Event attendee (the "Original Registrant") with an alternative person (the "Substitute Registrant") must be made in writing to [registration@airspaceworld.com](mailto:registration@airspaceworld.com). Requests are approved or denied by CANSO b.v. at its sole discretion. Requests must include (i) the Original Registrant's full name and registration number, (ii) documentation evidencing the Original Registrant's permission to substitute the Substitute Registrant, and (iii) the name of the Substitute Registrant. The cost of substituting the Original Registrant varies based on registration status of the Original Registrant. Any balance due will automatically be transferred to the Substitute Registrant. Once a badge has been issued, no substitutions are permitted.

6. **FORCE MAJEURE**
  - 6.1. CANSO b.v. defines Force Majeure as circumstances which are beyond the reasonable control of CANSO b.v. and which are reasonably likely to affect CANSO b.v.'s successful delivery of the Event or would make it inadvisable, impracticable, illegal, or impossible for a party to perform its obligations as originally contracted under these Terms & Conditions, including, but not limited to: failure of a utility service or transport or telecommunications network, lockout, strike or other industrial action (whether or not involving CANSO b.v.'s own workforce), civil unrest, fire, flood, storms, earthquakes, chemical or biological contamination, any restriction or measures imposed in connection with a pandemic, epidemic, public health emergency (including but not limited to the Covid-19 pandemic), act of God, riot, malicious damage, compliance with any law or governmental order, rule, recommendation, regulation or direction (including travel-related guidance and restrictions), accident, breakdown of plant or machinery, or default of suppliers or sub- contractors, sonic boom, acts of terrorism, acts of war, governmental action or advice.
7. **LIABILITY**
  - 7.1. The Organiser reserves the right to amend any section of the Event programme if necessary, at any time. The Organiser will not accept liability for damages of any nature sustained by delegates or accompanying persons, or loss of, or damage to their personal property as a result of the CANSO b.v. Event in question.
  - 7.2. Participants should make their own arrangements with respect to personal insurance, along with travel insurance. CANSO b.v. strongly recommends that delegates take out comprehensive medical and travel insurance, which should cover the possibility of flight cancellation due to strikes and other causes.
  - 7.3. We advise that you purchase, at your own expense, appropriate and sufficient insurance against any risk of loss associated with the Event being cancelled, postponed, rescheduled, or relocated.

Attendees may refuse to have their badge scanned in such a way.
- 8.5. By registering, Delegates give the Organiser and any other visitor including exhibitors and press permission to make use of their image in the production of audio, photography and video recordings during the CANSO Event and to publish these materials on the CANSO website and other publication channels and materials of the Organiser.
