February 14 in Crawfordsville 11am-2 pm "Boards that Rock: Board Building for 2017" Presenter: Susan Decker

Legal Obligations of Boards and Maintaining Ethical Integrity: This interactive seminar will explain the three basic legal duties of a nonprofit board of directors and how a board may fulfill these duties. First, the legal duty of care requires a board to exercise prudent care in its decisionmaking. Second, the legal duty of loyalty demands that board members put the interests of the organization above their personal interests. We will discuss how this legal duty is fulfilled by implementing a conflict of interest policy and procedure as well as a statement of ethics for the organization. Finally, we will examine the legal duty of obedience by looking at the role of bylaws, articles and compliance with the law of federal tax exemption. Questions and discussion will be encouraged.
