## Enrollment Form Expiration Dates

We wanted to take a moment to share some important updates regarding enrollment forms as we continue to prioritize the well-being and safety of our beloved children at the JCCC.

In our ongoing commitment to compliance with state licensing and the Georgia Department of Public Health regulations, it is crucial that all enrollment forms are kept up to date for every child enrolled in our center. We understand that staying on top of these requirements can be challenging, which is why we've implemented a system to help keep you informed.

Currently, families receive an automated 30-day notice from our Family Information Center (FIC) to remind you of any upcoming expiration dates. However, recognizing the significance of this matter, we're enhancing our communication efforts. Moving forward, we will proactively reach out to families via phone and email as expiration dates approach, ensuring no important deadlines are missed.

We want to emphasize the importance of ensuring that allergy, medical, and immunization forms are always up to date. **Effective May 1, We will have to pause enrollment for children with expired allergy, medical, and immunization forms. We plan to discuss this further at our all-parent meeting.**
