The overall condition of this 1966 Chevrolet C-10 1/2 ton pick-up is in good condition. There are no signs or indications of previously repaired crash damage. This vehicle has little wear and does not present any signs of hard use or abuse.

The overall exterior is clean and looks good. Bodylines and panel gaps are consistent and even throughout. This vehicle was repainted at some point and the vehicle has obviously been garaged. There are minor paint nibs to the left cowl area next to the left fender. The polished wood inlay in the truck bed is in prime condition. No exterior body rust was noted. The chrome trim is in good overall condition. The tires are good in terms of tread depth.

The interior is clean and in good condition as well. Please note that the radio is an aftermarket tape player and is fully functional as well. The interior seats are functional and in good condition just like the carpeting. There is no AC system and the heater does not appear to function.

The undercarriage and chassis have very minor corrosion/rust present with minimal leakage. The condition, however, is still considered in above average condition per the age of the vehicle.

The test drive was very good. The 327cid/4bbl, V-8 engine started promptly and idled well. No abnormal engine noises were observed. Exhaust smoke was unremarkable, and no other signs of issues were noted with overall engine function. Acceleration and performance were good. The 3-speed auto select transmission appeared to have engaged correctly. The power steering and brake systems (drums) operated as expected. The brakes may need adjusting but that it is considered typical as most would update to a powered disc brake system.

The subject vehicle's options and features appeared to function correctly with the only exception of the no heater and non-functioning reverse lights.

This is a decent-looking and running vehicle that shows minimal overall wear.




