DU Continues To Grow, Flourish At Cornell

Dear Brother,

The good news at DU continues. The chapter's accomplishments during 2005-'06 are impressive and gratifying.

In January, we had a record-breaking recruitment, resulting in 26 new member associates—the largest pledge class on the hill! In this *Noose*, you can read about the new members and the successful recruitment program headed by Lance Polivy '08.

Our 75 brothers are diverse, balanced, and engaged in chapter activities. Thirty-seven are living in the house. Eighteen seniors will graduate this semester.

The importance of scholarship in DU and the chapter's success academically during the past year is presented in this issue. We now rank 15th of all fraternities at Cornell. The chapter is into its third year of operation since reopening in August 2003. We are blessed with strong and capable officers, both outgoing and incoming.

The new academic year begins each August with an all-brothers/alumni directors retreat. On Friday, February 10, 2006, DU alumni hosted our annual wel-

coming dinner at the Statler for our 26 new members (pledges). On Sunday, February 12, 2006, we held our undergraduate officers/alumni directors retreat.

Each of these events was a terrific success, reinforcing teamwork between alumni and undergraduates as our management culture. At the officers/alumni directors retreat, the brothers ran the meeting with alumni now assuming a support role.

Initiation on April 8 was very impressive, with 26 new brothers and many parents attending. Charlie Joyce '72, whose son, Casey '09, was in the new member class, delivered an excellent charge about making good choices and taking risks in life. "DU alumni took a risk in re-starting the chapter; our first core group of 15 and the others in the initial pledge class, initiated in December 2003, took a risk in joining a new DU. We all take risks in life. It's part of life, and that's good. Look how it's paying off very positively here in DU."

On April 11, Randy Shayler II '07 was elected president and Lance Polivy '08 vice president. Both did terrific jobs previously as treasurer and vice president of recruitment and will be great leaders in their added responsibilities. All officers are now elected for one-year terms extending from April to April. This enables more logical

transitions and better continuity with CU OFSA and DU reporting requirements.

Bill Schenkel '66 is leaving the board after 30-plus years of service because he feels it is time to rotate off and make room for some younger DU alums. Bill told me, "It's been a truly fantastic experience and a privilege working with the other alumni officers and everyone else associated with DU over these many years." Hopefully, Bill's example will inspire two or three alums who are interested and willing to work with DU undergraduates to join our board of directors.

Bottom line: The chapter is once again in good shape. The undergraduate articles in this issue provide the best evidence of the chapter's accomplishments and the quality and character of the brotherhood. I am extremely optimistic about our future.

I want to thank Lou Morga '07 and all the chapter officers for a terrific job in 2005-'06. Also, my sincere appreciation to DU alumni everywhere for your continued involvement and support.

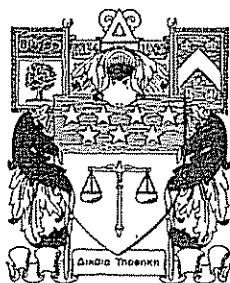
The second milestone is the success the new DU chapter has achieved after just three years of operation. As you read the articles in this *Noose*, you will be impressed by the accomplishments,

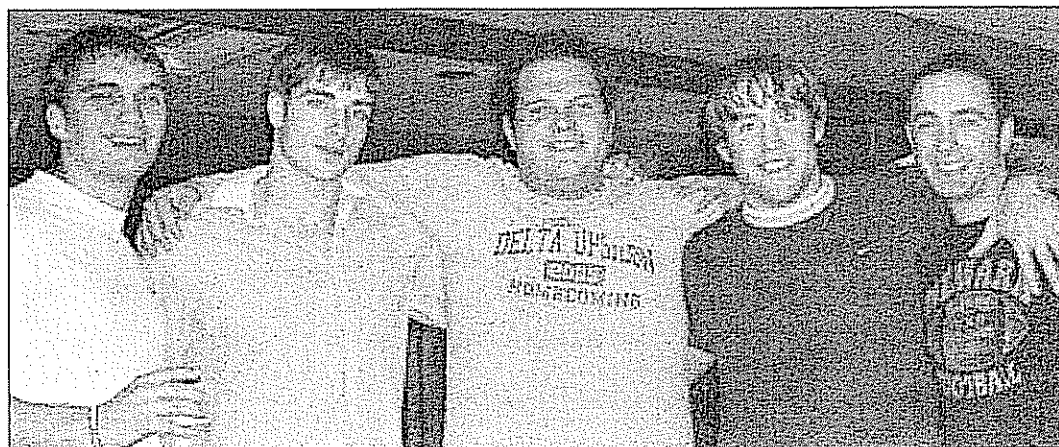

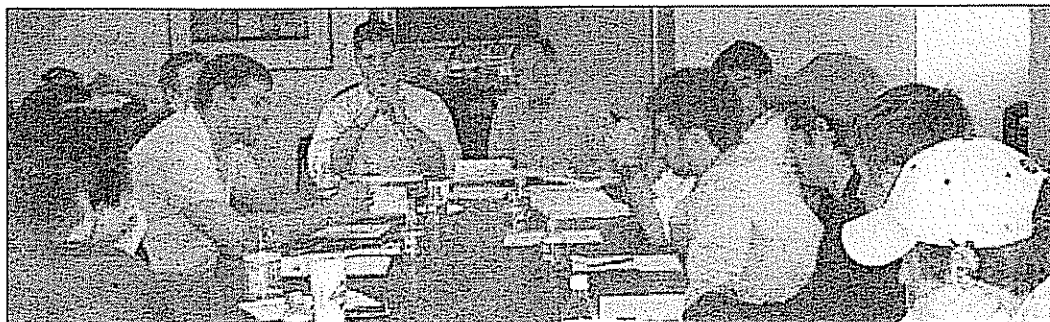

The chapter received an overall rating from OFSA (Cornell Office of Fraternity and Sorority Affairs) of a category two on a scale of one through five based on its 2004-'05 year-end report. Officers are currently completing our report for 2005-'06. While category two is a very good rating, they are anticipating a category-one rating for this year.

Jared Goodman, our resident advisor from USC '01, is completing his first year in the Cornell MBA program. He is doing an excellent job, has gained the confidence of the undergraduates, and has agreed to continue as our RA again next year.

Chapter officers attended the February 11 A.D. White Leadership Conference. During this weekend, we hosted the new members dinner on Friday and the officers/alumni directors retreat on Sunday.

Dave Binder '07, DU vice president

and past philanthropy vice president, received one of two honorable mentions for the John Dyson Citizenship Awards—recognizing his outstanding work and leadership with DU brothers and then as IFC director of community and university relations during the spring '05 semester.

The undergraduates have submitted two comprehensive DU reports for 2005-'06 to Cornell's OFSA as well as to the Delta Upsilon International Fraternity (Chapter Excellence Plan).

Our directors attended the April 21, 2005 annual meeting in New York City prior to our spring dinner that evening. In addition to reviewing the status of the chapter, capital campaign, and financials, we discussed the opportunity to expand our directors' involvement with the

undergraduate chapter. Directors are now signed up to assist in the 13 chapter operational areas.

The mentoring program continues under the direction of John Honchariw '06 and Dan Gilroy '86. Peter Vogel '92 and Chip Stevens '92 spent a Friday night with brothers and had a good discussion session with about 20 of our undergraduate brothers on Saturday afternoon. Peter and Chip got great feedback and appreciation!

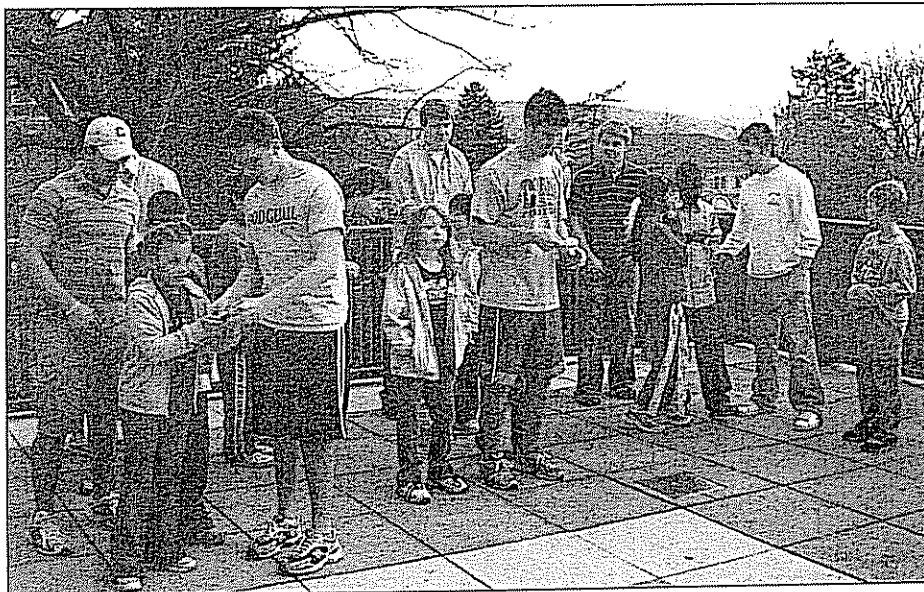
DU Continues Its Award-Winning Philanthropy Program

This semester, Delta Upsilon kept its philanthropy program strong by continuing with some old traditions and adding some new ones as well.

The brotherhood kicked things off with the annual "Cards and Cookies" event with our neighbor on South Avenue, Kappa Alpha Theta. The event was a huge success, as the dining hall was filled to capacity with members from both houses. Together, the two groups made over 60 cards and 90 cookies for the local Oak Hill Nursing Home.

For the second straight year on Valentine's Day, the new members organized a flower sale that fulfilled the philanthropy event requirement of the new member program. Led by our new member philanthropy chair, Jonathan Ray '09, the pledges put on an enormously successful sale. All of the money raised was donated to the Ithaca Youth Bureau.

The biggest philanthropic event of the semester was the annual Easter Egg Hunt, in which the entire brotherhood participated. Done in coordination with the Ithaca Youth Bureau, over 30 children invaded the chapter house one Saturday afternoon and participated in a variety of events—like egg painting, relay races, and, of course, a hunt for eggs and candy. The brotherhood hid candy and over 200 eggs throughout the chapter house, and the kids found everything, having a great time in the

process.

The final event for the semester took place hours after the Easter Egg Hunt. Much of the brotherhood hadn't had enough philanthropy for one day, so they headed over to Barton Hall for Relay for Life, a campus-wide event that benefits the American Cancer Society. The object of the relay is to have someone from your team walking around the track at all times for 12 straight hours to symbolize the long fight that cancer patients endure. With over 2,000 people participating

throughout the campus, Delta Upsilon raised the highest money total among fraternities.

This semester was packed with philanthropy events, all of which were successful and benefited many different people and organizations around campus and in the Ithaca community. DU has the strongest philanthropy program at Cornell, and it does not appear to be slowing down anytime soon.

DU Brothers Remain Academically Strong

The scholarship of the brotherhood progressed a great deal this semester under the leadership of Charles G. McClure IV '08, vice president of scholarship.

The most obvious indication of how well this semester went academically was the significant improvement in the house's grade point average. The house GPA increased from a 3.116 to 3.295—jumping from 27th place all the way up to 15th out of all the fraternities at Cornell. Another impressive statistic is that over 44 brothers received a GPA of 3.0 or higher—with three of them obtaining a 4.0 or higher.

Mark Levendorf '08 received the highest GPA award, while Ross Hamilton '06 earned the most improved GPA award. Of the new members initiated in the fall, Peter Schrafel '08 had the highest GPA.

Another improvement in the house's scholarship program was the requirement that each new member complete two study hours every week. Although it was expected that new members would study far more in a week, it served two purposes: First, it ensured that they would study a bare minimum of two hours, and, more importantly, it sent a message to new members that study is

taken very seriously by the brothers of Delta Upsilon.

Another method of support for new members was taken three weeks before initiation, when Brother McClure met with each new member individually to make sure that he was performing well in the classroom, while at the same time providing academic assistance and advice. The importance of academics was impressed upon the new members, since it was felt that setting the tone early at DU would serve them well for the remainder of their Cornell careers.

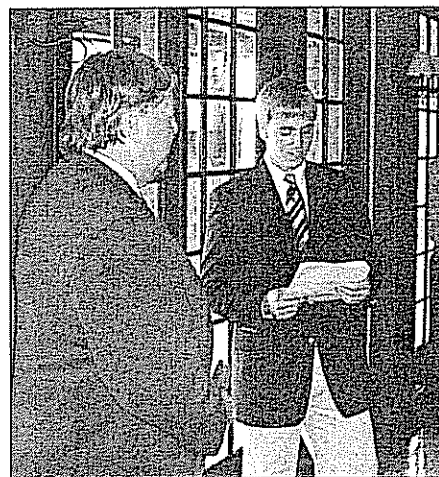

These are all direct DU legacies. We are also fortunate to have Jim Hyland '07, whose father is a DU from Penn State.

The class of '72 connection is amazing. It had 26 pledges and three legacies (Rod Clemente, Mike Murphy, and Scott Schnuck), exactly the same rush results as this year. The '72 class is notable in other ways. It experienced the infamous Willard Straight Hall event and campus demonstrations, which I am told united the class. Three

years ago, 20 '72 brothers returned for the Ben Mintz/CFA golf outing in Ithaca, and they still stay in touch. Charlie Joyce, who delivered the initiation charge but who had missed his own undergraduate initiation, was given the DU oath in a surprise ceremony by his son, Casey, who himself had just been initiated. Randy told me it was a "Hallmark moment."

I spoke to several of the legacy fathers. None pushed their sons toward DU, wanting them to make up their own minds about fraternities and even about attending Cornell. All were thrilled when their sons selected DU. When Duane Phillips visited Cornell from San Francisco, he was particularly impressed with the diversity of the chapter. He said, "DU is just like it was when we were undergraduates, except they are smarter."

I can't think of a better testimonial for DU than when younger brothers like Dan and Nick join while their older brothers who are still DU undergradu-

DU Executive Board Meets For February Retreat

On Sunday, February 12, 2006, the DU executive board woke up bright and early to meet in a Willard Straight Hall loft to discuss the state of the chapter. The outlook for the chapter is incredibly positive.

Presentations were made by each officer, outlining progress and goals for the upcoming semester. Additionally, the executive board and the alumni attending the retreat discussed some of the opportunities for improvement in the future. The alumni participants

included Tony Murray '60, Tony Cashen '57, Randy Shayler '72, Bob Verna '68, and Frank Cuzzi '61.

Highlights included a recruitment recap on the efforts of the entire brotherhood; a presentation on our great work in public relations—as evidenced by articles published in *The Cornell Daily Sun* and *The Ithaca Journal* about DU; and a discussion of our improving relations with sororities.

Randy Shayler's presentation on his work as treasurer was another high-

light. Our financial management was previously recognized at Cornell as the strongest on campus, mostly due to Randy's great work. We also discussed our new constitution and possible changes to our internal judicial process.

Everyone felt the retreat was a huge success due to the impressive presentations, discussions, and progress made accomplishing most of the officers' objectives for this school year.

Program Aids Member Education

The member education program has made significant strides this semester and has been very successful in enriching the brotherhood in a variety of ways.

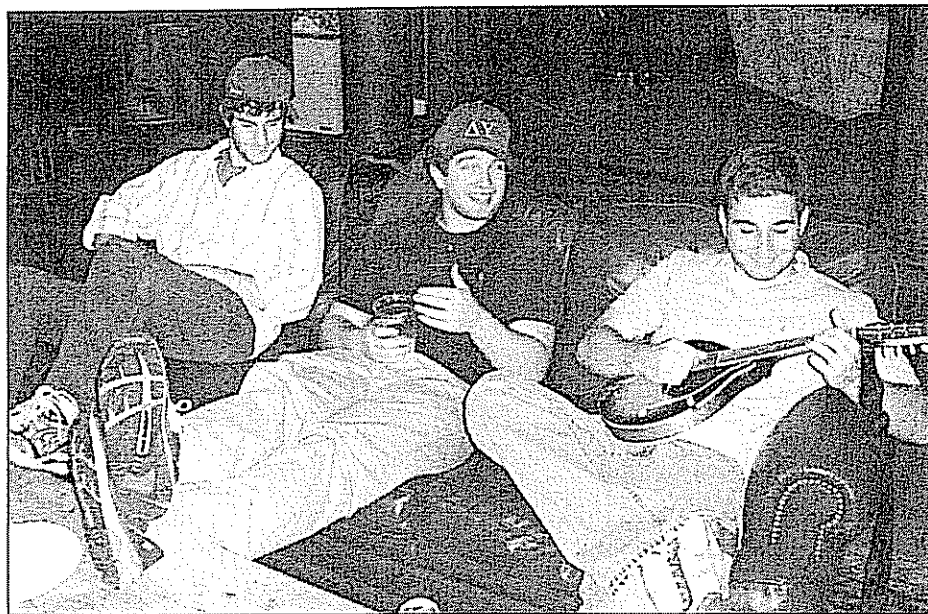
At the beginning of the spring semester, alumni Chip Stevens '92 and Pete Vogel '92 returned to the chapter house to speak to the brotherhood about their respective careers and fielded questions about their lines of work and personal experiences after graduating from Cornell.

In February, Fred Antil '55 joined us for a Sunday formal chapter dinner and discussed some of his life after graduating from Cornell. Brother Antil also brought some excellent pictures to show the brotherhood and told some great stories about life in the house during the 1950s.

In April, the member education program held a Passover Seder in the dining room that was open to all brothers. More than a dozen brothers attended, along with several female guests, and the event was very successful in teaching the brotherhood about a unique religious tradition.

The member education program also has several events planned for the future, including a discussion with Tim Marchell '82, director of mental health initiatives at Cornell, who has come by the chapter house on numerous occasions to speak to and hang out with the brotherhood. Another possible event is a talk given by Gali Porat, an ILR researcher who would give the chapter a presentation on prescription-drug abuse.

Perhaps the most important task facing the member education program in the future is the search for a chapter faculty advisor. Several candidates have been considered for the position, and the chapter hopes to finalize its choice and secure an advisor by the fall.

Brother Promoted To NFL QB Coach

Bill Lazor '94 was promoted to Washington Redskins quarterbacks coach in January 2006 after spending the 2004-2005 seasons as an offensive assistant with the Redskins.

In 2003, he was with the Atlanta Falcons as offensive quality control coach. He joined colleague Rennie Simmons in coming to Washington from Atlanta. While his resume lists only three years coaching on the pro level, Bill is more than comfortable working with high-profile players.

In 2003, he worked with a number of notable NFL standouts, including Michael Vick and Warrick Dunn and Pro Bowler Alge Crumpler. Before jumping to the NFL ranks, Bill was offensive coordinator-quarterbacks

coach for the University of Buffalo from 2001-2002.

Previously, he served in numerous coaching capacities at Cornell. Following his graduation, he joined the coaching staff full time, working with the receivers, running backs, quarterbacks, and tight ends. In addition to his coaching duties, Bill was also the recruiting coordinator from 1998-2000.

Bill enjoyed a record-breaking career as a quarterback for Cornell from 1991-1993, setting 26 school passing and total offensive records. Bill earned his bachelor's degree in human development and family studies. He and his wife, Nicole, live in Ashburn, Virginia.

Brother Recognized At Leadership Conference

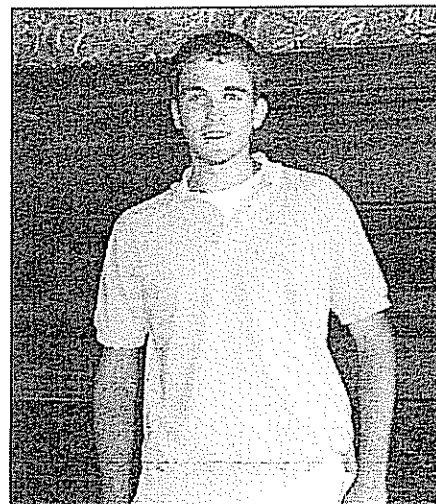
