Even though not reflected in the statement of financial position, the museum's collections represent one of its most valuable assets. Purchases of collections items are reported as decrease in net assets without donor restrictions, or as decreases in net assets subject to specific time or purpose restrictions. It is the museum's policy not to sell collections items. Any proceeds from deaccessions or insurance recoveries are reflected in increases in the appropriate net asset classes.

Schedule D, Part III, Line 4 - The museum's collection is encyclopedic in that it spans time frames from antiquities to modern art, and includes works from a variety of cultures and countries of origin. It is comprised of statues, paintings, works in ceramics and other media.

Schedule D, Part V, Line 4 - Each year the Board traditionally allows the museum to draw 4.5% of the endowment. Draws may be spent according to the restrictions placed by the donor on those funds., those generally being support of museum operations, costs of exhibitions and the cost of acquisition of art. Unspent portions of the 4.5% funds can be carried forward to subsequent years for expenditure. In unusual circumstances, the Board has authorized additional amounts to be drawn from the Endowment.
