We also invest in interesting projects outside of construction and real estate.

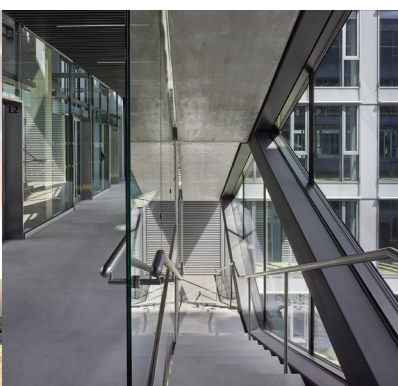
## SPORT
