RESOLUTION NO. 2009-05

A RESOLUTION AMENDING THAT SECTION OF RESOLUTION 2008-06 REGARDING THE NUMBER OF TOTERS TO BE PROVIDED TO RESIDENTIAL DWELLINGS SERVICED BY THE MUNCIE SANITATION DEPARTMENT FOR USE AS SOLID WASTE CONTAINERS.

WHEREAS, the Muncie Sanitary District has previously passes on April 22, 2008 **RESOLUTION NO. 2008-6** which amended RESOLUTION 2008-01, a Resolution relating to solid waste collected by the District; and

WHEREAS, said **RESOLUTION 2008-06** in part established the number of solid waste containers ("toters") to be provided by the Muncie Sanitary District to each dwelling serviced by the District; and

WHEREAS, the Muncie Sanitary District finds that increasing such number of Toters provided without additional fee will better provide for the collection of solid waste and better protect the health, safety and well being of the customers served by the Muncie Sanitary District.

NOW THEREFORE, BE IT RESOLVED by the Board of the Sanitary Commissioners of the Muncie Sanitary District that:

Section 5 C.), Toters be amended to read as follows:

"For regular solid waste pick-up service by the Sanitation Department, each single family dwelling, multi family welling containing four (4) or fewer living units and each non-dwelling unit shall have no more than two (2) 96 gallon and/or 64 gallon Toters and each multi family dwelling containing between five (5) and eight (8) dwelling units shall have no more than four (4) 96 gallon and/or 64 gallon Toters, unless additional Toters are leased through the Muncie Sanitary District for an additional fee of \$5.00 per month each (or the then existing additional fee as it may from time to time be established by resolution of the Board of Sanitary Commissioners). Accessory structures and vacant lost shall not be entitled to Toters."

Section 13.B.), Construction Waste and Large Items be amended to read as follows:

"Large quantities of solid waste, rubbish, trash, debris, or other refuse over and above the number of toters allowed to dwelling units and non-dwelling units free of charge may require the leasing of additional Toters at an additional fee per each additional Toter."

Section 15. Non-MSD Solid Waste be amended to read as follows:

"Collection of solid waste shall be available to all customers who generate waste that is containable in the number of Toter provided free of charge by the MSD. If a customer needs additional Toters they may be leased through the MSD. Solid waste from sources outside the district limits shall not be collected. Such outside waste shall not be placed at any customer's dwelling or non-dwelling units anywhere within the district limits or any other authorized place of collection served by the Sanitation Department. A customer that violates or permits the violation of this section of this policy may forfeit the privilege of collection services by the Sanitation Department, at the determination of the Board of Sanitary Commissioners."

BE IT FURTHER RESOLVED BY THE BOARD OF SANITARY COMMISSIONERS OF THE MUNCIE SANITARY DISTRICT that this Resolution shall be in full force and effect from and after its passage by the Board of Sanitary Commissioners.
