2. Pre-registration Information

2.1. Families Program Registration Eligibility

The Families Program offers a range of services exclusively to Family Members of the Athletes and Participants involved in the Special Olympics World Games Abu Dhabi 2019. Individuals eligible to register and to be provided with the Families Program benefits are defined as any individual who is related to an athlete participating in Special Olympics World Games Abu Dhabi 2019, as follows:

- 1. The husband, wife, partner, child of the athlete
- 2. A blood relative of the athlete (i.e., mother, father, sibling, grandparent, uncle, aunt, nephew, niece, cousin and a relative related by marriage or a partner of a blood relative)
- 3. The athlete's legal guardian, foster partner or caregiver
- 4. An individual involved with the athlete in a parenting role

The categories of participants that will be welcomed into the Families Program include family members of:

- Competing Special Olympics athletes
- Athlete Officials
- Athlete members of the Law Enforcement Torch Run Final Leg Team
- International Global Messengers

2.2. Registered Families Program Member Benefits

Registered Family Members are provided with the following benefits:

Accommodation Assistance

The Local Organizing Committee (LOC) will provide to registered family members housing options at reduced rates at the Official Families Hotels. A weblink and relevant booking information will be sent to the National Family Coordinators once the official hotels are confirmed.

Access to the Families Program Welcome Center

The Families Program Welcome Center serves as the initial check-in area. This is where credentials and Welcome Packs will be distributed to all registered members.

Access to Free Transportation

The Families Program credential allows access to the free inter-venue shuttle service throughout the Games, which also connects the competition venues and the Official Families Hotels. This shuttle service will further be connected to the existing Abu Dhabi public bus network, so that credentialed family members not staying at the Official Families Hotels can access the service. Details on Families transportation options will be provided closer to the Games through the Family coordinators and the Families page on the website (www.abudhabi2019.org).

Access to Families Program Hospitality Areas

The Families Program credential allow access to Families and Honored Guests Lounges, which are available at competition venues and serve as places to rest, gather and network. Light refreshments will be served at lounges, and information desks will be available.

Designated Seating for Families within the Venues

The Families Program credential gives access to dedicated Families and Honored Guests seating areas at competition venues.

Engagement Activities

Family Members are invited to enjoy and participate in Family-related activities held in conjunction with the sporting competitions. The LOC is currently finalizing the benefits of the Families Members and further details will be provided through the National Family Coordinators.

Host Town Program

The Host Towns program is dedicated to Delegations only. Therefore Families will not be able to participate in the Host Town program.

2.3. Non-Family Members Information

Non-family members, such as friends of Families Program participants, are welcome to attend the Games as spectators, but will not have the above-mentioned benefits that Family Members are given.

3. Registration Process

Families Program registration will be done only through an online system (SO Connect). The Families Program Services Department of the LOC will send the registration link to the National Family Coordinators who will be responsible for disseminating it to Families.

After the Family Members submit their forms online, they will receive an automated confirmation of receipt. Following validation by the National Family Coordinators, the Family Members will be considered registered.

All registration forms must be submitted by **December 31**st, **2018**, as also indicated below.

If Family Members require assistance with completing the Registration Form, they should contact their National Family Coordinators assigned to them.

3.2. General Registration Instructions

All Families Program participants must register online using SO Connect. No other methods of registration will be accepted.

Before you begin:

In order to complete the online registration, please have the following information ready prior to starting your registration:

- Contact information including address, phone number, email and emergency contact
- Information about the athlete you are related to (name, sport, etc.)
- Travel information, including flight information and arrival/departure dates
- Hotel information
- Digital photo to upload for your credential (see photo requirements listed below)

• Passport information and a photo-copy of the information page of the passport to upload



All required fields in the system must be filled out. Also all information must be completed in English.

Please ensure that ALL registration forms are 100% complete. If you need assistance in completing the online registration, please reach out to your National Family Coordinator who should be your first point of contact. Photo Requirements

- Load digital color image in JPG format and at least 300 DPI or 800 x 600 pixels
- Passport-size photos must be scanned and uploaded in JPG or PNG format
- Each individual image should be saved using the following naming convention: COUNTRYCODE_SURNAME_ FIRST NAME_DOB (e.g., JPN_OTA_04JUN1980)
- The headshot photo should NOT be cropped from the passport
- Photos must be clear of stamps

Headshot Photo Requirements

The headshot photo is used for credentialing. Please read the guidelines and follow the instructions below:

- Head should be positioned directly facing the camera
- Photo should capture from slightly above top of hair to middle of chest
- Eyes should be open and looking at the camera
- Eyeglasses should be worn if normally used by the individual
- Glare on eyeglasses can usually be avoided with a slight upward or downward tilt of the head
- Background must be plain white
- Must be a **colored photo**
- Include headpieces if worn daily for religious purposes; they should not obscure or cast shadows on the eyes or any other part of the face
- Medium resolution photography and printing are strongly recommended
- Digitally printed photos should be produced without visible pixels or dot patterns
- Fine facial features should be discernible
- The entire face should be in focus
- Photo size must be 1.6 inches (4cm) x 2 inches (5cm)

A slight downward tilt of the head will usually eliminate glare on eyeglasses. If this does not reduce the glare, try tilting the head slightly upward or rotating the glasses slightly upward or downward. The head should not be tilted by more than a few degrees to eliminate glare.

Red Eyed conditions should be avoided. Red eye is caused by a direct reflection, through the pupil, from the retina of the eye when an oncamera flash is used, particularly for a subject who has adapted to a darkened environment. Red eye can be reduced by using an off-camera flash or by brightening the ambient lighting.



A distracting background should be avoided. Use a plain wall or a photographer's backdrop cloth as the background. The background color may be white or off-white.

Ideally, the background will be out of focus so that minor markings or texture on the background are not apparent in the photo.

4. Travel to the UAE

4.1. Accommodation and Travel Information

Family Members are responsible for making their own travel arrangements to and from Abu Dhabi, including visa processing, flight and accommodation booking.

Accommodation options at reduced/discounted rates will be sent out to the National Family Coordinators.

4.2. Visa Information

Family members are responsible for making all necessary arrangements to obtain visa, if this is required. If there is a charge for the visa, the individual is responsible for that cost. In addition, the LOC will not issue letters or any other support.

Citizens of the following countries can get a 30-day visit visa on arrival, free of charge and renewable for similar period.

Citizens of the following countries can get a 90-day multiple entry visa valid for 6 months free of charge, from the date of issue for a stay of 90 days.

Citizens of Gulf Cooperation Council (GCC) countries do not require a visa. They need to present their GCC country passport or national ID card at the point of entry into the UAE.

Expatriate residents of GCC countries need to apply for visa online and obtain the same before arriving in the UAE.

The above list and visa information may vary from time to time; therefore, it is advisable to check with your travel agency, the airline you are flying with or the <u>UAE embassy</u> before travelling to the UAE. Also please visit the <u>Ministry of Foreign Affairs</u> website for latest information on visa requirements.

Note that even if a country does not require a visa, the family member passport information will still need to be provided as part of the registration process.

Visas through Airlines

When booking through any of the following UAE-based airlines, check for the types of terms and conditions for entry permit or visa. Also enquire about documents you need to provide them. Follow the below links for more information:

Visas through Travel Agencies

Licensed travel agents in the UAE can arrange an entry permit, or visa, if you purchase the air ticket through them. You may also contact travel agencies in your country for tourism packages to the UAE who can arrange an entry permit, or visa, in collaboration with a tour operator in the UAE.

Visas through Hotels

Selected only hotels in the UAE may be able to aid in the visa application process at a cost. However, it is generally advisable to apply for a visa through the embassy, your local travel agent or the airline you intend to use for your travels.

4.3. Etihad Airways

Etihad Airways is the Official Partner Airline for the Special Olympics World Games Abu Dhabi 2019, and is offering 10% discount to Families and Friends for bookings made before March 7, 2019 and travel between March 9 and 26, 2019.

Discount is available in Economy and Business classes from any direct flights into Abu Dhabi.

4.4. Arrival to the UAE Airports

The two official airports in the UAE are Abu Dhabi International Airport (AUH) and Dubai International Airport (DXB).

The distance between Dubai and Abu Dhabi is approximately 140 km and it usually takes between 1hr15mn and 1hr30mn by car.

How to reach Abu Dhabi City from Abu Dhabi airport:

Taxi

Getting around Abu Dhabi is easy, and taxis are reasonably priced and plentiful. They can be flagged down at the roadside, booked by phone through the TransAD hotline 600 535353 or via

the Abu Dhabi Taxi app available for both iOS and Android platforms. The cost of the trip from Abu Dhabi airport to the city center is approximately 85dhs (cost in only indicative and may change depending on final destination/route and traffic). While some taxis take credit cards, it is recommended to have cash (dirham) on hand.

Bus

Public buses operated by DOT (Department of Transport) are available to cater to the needs of the community in different parts of the Emirate of Abu Dhabi, including the airport. One single bus ride costs 2dhs. You can download their application" Moovit" and have access to a city-wide bus map.

How to reach Abu Dhabi City from Dubai airports:

Taxi

Dubai Taxi is operated by DTC (Dubai Taxi Corporation). There is plentiful of taxis at the exits of all terminals. While some taxis take credit cards, it is recommended to have cash (dirham) on hand. The cost of the trip from Dubai airport to Abu Dhabi city is approximately 350dhs (cost in only indicative and may change depending on final destination/route and traffic).

Public Buses, Tram, Metro

Dubai Public buses, Trams, and Metro are operated by RTA. You can access RTA services using "Nol card" which is a smart card that enables you to pay for the use of various RTA transport modes. You can also book and plan your trips via the "RTA Mobile app". The Tram and Metro do NOT connect Dubai and Abu Dhabi, however public buses do.

Flying with Emirates Airlines

If you are flying to Dubai with Emirates airlines, there is complimentary coach services for Economy Class passengers holding a flight ticket. Visit the below link for shuttle timing and pick-up/drop-off points: <u>Emirates shuttle service</u>

All business and first-class travelers receive complimentary chauffeur drive that also includes transportation between Dubai and Abu Dhabi.

Careem

Careem is a popular transportation provider in both Abu Dhabi and Dubai. The Careem phone App enables users to book rides within a matter of seconds from anywhere by matching them with Captains to take them where they want to go. The process is quite simple: When you wish to book a ride, open the app and input your pickup and drop-off locations, then send the request by tapping a single button. Nearby Captains see this request, accept your booking, and immediately starts driving towards you. The rate between Dubai airport and Abu Dhabi City is between 380dhs and 480dhs (cost in only indicative and may change depending on final destination/route and traffic). It is advisable to contact Careem as they may also offer different rates from trips between Dubai airport and Abu Dhabi.

5. Medications in the UAE

If you are on permanent medication prescriptions, please make sure you either bring the required quantities or the relevant doctor's prescription to cover your stay in Abu Dhabi as some of the medications cannot be purchased without a valid prescription.
