Requirements for Level I

- You must be listed on the National list of Judges of your country for at least 36 months (since the date of notification to ECAHO).
- You are not or have not been a Professional trainer or handler for the past 3 calendar years.
- You must have judged a minimum of three ECAHO affiliated Shows as a National Judge.

Requirements for Level II

- You must have passed ECAHO Course Level I.
- You must have undergone probations with different A Judges; number of required probations is given by Instructors after passing Level I. Please make sure that ECAHO Office received the reports.
- You must have experiences from national and international Shows.

General requirements

The course is conducted in English. The participants are required to use English on good communicative level and be familiar with terms concerning conformation, skeleton, movement etc.

After the course the Instructors will evaluate all participants. The Instructors will consider results of the practical judging, theoretical knowledge, communication skills and general attitude. Successful participants of Level II may be recommended (after all requirements are fulfilled) to the EAHSC for acceptance to ECAHO B list of Judges. Judges will be proposed for inclusion into Blue Book 2021 at the SC meeting in Paris (World Championship).
