


## IN DEDICATION



With our focus this year on leadership, we dedicate the 2006 Annual Report to Robert A. Nicholson. In his recently released memoir, *So I Said Yes!*, Nick refers to the Foundation as "a major force for good in the community." His low-key manner prevents him from claiming adequate credit for creating that force. Just two years after retiring as Anderson University's president, Nick assumed the highly visible role as founding president of our board, a position he executed with enthusiasm from 1992 to 1997. During that period he guided us through the complexities of incorporation, recruited a strong board from his wide circle of associates, designed a solid governance model and was instrumental in securing our first gift of \$250,000. At the time of his retirement from board service, he had watched the endowment grow from zero to \$10 million. We are grateful to Nick for recognizing the Foundation's potential "for good in the community" and for saying "yes" to our request for leadership

## • EXECUTIVE MESSAGE

### WE LEAD BY BUILDING MOMENTUM

Your Madison County Community Foundation took to the road this year to build momentum for several ambitious projects that have the potential to benefit our region for generations to come. Education was at the core of many of these activities, as the stories in this report will illustrate. As part of our travels we:



Presider

- visited every high school in the county to demystify the college-application process for students and their families;
- met with representatives of five school districts as they designed innovative programs aimed at preschool children;
- arranged a grant-writing workshop at Ivy Tech for 40 nonprofit agencies to boost their effectiveness in serving residents;
- reconvened the Women in Philanthropy Forum and facilitated the group's decision to award a scholarship to a woman preparing for a healthcare career;
- hosted a professional seminar to update financial advisors and estate planners on opportunities for clients to maximize donor dollars.

This stepped-up agenda was made possible by the Foundation's growing assets and its expanding network of leaders. Since last year's annual report, we have welcomed 203 first-time donors to our rolls and have created at least one new fund each month. Foundation assets now exceed \$13.5 million, an increase of \$1 million over last year's record total. A gift of \$519,000, the second largest in the history of the Foundation, was instrumental in this growth spurt. We're grateful to Robert John for his thoughtful legacy on behalf of Madison County students. Details of his generosity are on Page 21 of this report.

Key leaders assumed responsibility at every turn. Dave Murray, an expert in college affordability, accompanied us to eight high schools and introduced families to a formula that estimates higher-education costs. Guidance counselors joined us for lunch to discuss financial aid and scholarship opportunities for college-bound students. Jeanne Lee, founding executive director of the Foundation, accepted the chairmanship of the Women in Philanthropy Forum. Pam Davidson, a consultant from Bloomington, and Bobbie Donahue, a faculty member at IUPUI's Center on Philanthropy, led two Foundation-sponsored seminars.

A grant from Lilly Endowment has allowed us to dedicate funds toward donor development, enabling us to contact and educate more of our Madison County contributors and supporters. We are pleased to add for the coming year two additions to our governing board—Anderson architect Jesse Wilkerson and Elwood bank officer Tom Cassidy.

Ralph Waldo Emerson once observed that "The task ahead of us is never as great as the power behind us." As we crisscrossed Madison County during 2006 we encountered powerful local leaders who have the talent and motivation to accomplish every task ahead. We look forward to supporting their efforts.

BY SETTING

AN EXAMPLE



The idea of establishing a new fund to benefit persons with disabilities first surfaced on the ski slopes of Colorado, generated support at a fantasy baseball camp in Florida and now is a reality at the Foundation.

Bob Pensec, president of the Foundation and avid skier, took training in January to become a volunteer instructor in a

Colorado program that allows disabled persons to enjoy the sport. The experience, coupled with his awareness of the work done by the Gateway Association, prompted Pensec's interest in starting a fund to serve disabled citizens in his home community. A conversation with Carl Erskine, a long-time advocate for the disabled, at a Dodger baseball camp in Florida increased his enthusiasm. The result is the Jimmy Fund, named in honor of Carl and Betty Erskine's youngest son.

"We set it up to assist persons of all ages," explains Pensec. "The Foundation's grants committee will decide who will receive funds and the amount of each grant."

Pensec also discussed with Erskine and Paul Gray, coordinator for the Madison County Special Olympics, the advantages of creating a permanent endowment to provide ongoing support for the local Special Olympics. Because of efforts by Erskine and Gray, the program was on solid financial footing, although the money was earning only modest interest. That is likely to change since Foundation investments typically outperform the market. "The Foundation now will invest and manage the funds," says Gray. "That takes a big burden off of us."

The creation of the permanent endowment also removes a burden of a different kind. "Carl has been a major part of our fundraising," says Gray. "We're both aging, and one of our concerns has been the continuation of Special Olympics in Madison County after we're no longer active. Moving the funds to the Foundation ensures that continuation."

HEROES



As a reflection of Madison County's expanding diversity, participants in the annual Dr. Martin Luther King Jr. Citywide Celebration now sing "We Shall Overcome" in Spanish and English and hear the invocation delivered in both languages. A grant from the Community Foundation's Downtown Anderson Fund helped support the event, which for the past 15 years has been a January tradition at the Paramount Theatre Centre.

'We honor Dr. King not only as an African-American hero but also as an outstanding representative of a diverse nation,"

says Donald Volk, long-time member of the event's planning committee and executive director of the Paramount Heritage Foundation. "Few occasions in our community bring so many people from so many cultures together in one place, at one time, to focus on the contributions of Dr. King."

At the heart of the celebration is a one-hour service that is attended by hundreds of area students, state and national government officials, local leaders and citizens. Among this year's guest speakers were Anita J. Harden, president of Community Hospital East, and Jesse Wilkerson, an Anderson architect and newly named member of the Community Foundation's board of directors. Both used their personal stories to underscore the belief that "if you have a dream, you can achieve it," says Volk.

Although the event was never at risk of cancellation, a change in the local business community caused a major sponsor to withdraw its funding this year. Planners were faced with the possibility of scaling back some aspects of the celebration. Instead, several organizations stepped in to fill the gap. "This as a real community endeavor," says Volk. "It's an important citywide effort to make sure we never forget the achievements of Dr. King and to bring people together to celebrate his legacy."

BY CREATING

OPPORTUNITIES



**Elwood's full-day kindergarten program** expanded from one class to three this year, thanks in part to matching funds provided by the Community Foundation. Each of the five school corporations in Madison County accepted the challenge to design a program to improve early childhood education and to raise financial support for it. The Foundation's board of directors agreed to match, dollar for dollar, contributions up to a certain level for three years. Coupled with donor gifts, the initiative represents an investment of \$1.5 million in education in Madison County.

"We recognized that student reading scores were severely below what they should be," says Angie Collins, chair of Elwood's

SEED program (Success in Education through Enrichment and Development). "We started thinking about our project in early May and were able to raise enough money in four and a half months to get it up and running." An anonymous gift of \$13,000 jumpstarted the fundraising effort and led to a community response that Collins describes as "wonderful."

The expanded kindergarten day allows teachers "to do in-depth work with reading, writing and math skills to ensure better learning," explains Jan Kaye, director of special services for Elwood Community School Corp. "Our early anecdotal reports indicate that the youngsters are making tremendous strides."

Collins agrees with Kaye's assessment and offers firsthand evidence. "I have a daughter,

Isabelle, in the program and I'm seeing remarkable results already," she says. Documentation of student progress will come when the school corporation completes its state-mandated evaluations in 2007. At that time Kaye will share data about the effectiveness of full-day kindergarten with colleagues from other school districts in the county. The educators have met regularly since they collaborated on the CAPE initiative (Community Alliances to Promote Education), a program that originated at the Foundation in response to a Lilly Endowment challenge.

"The spirit of cooperation that began with CAPE seems to get stronger every year," she says.

BY CONVENING

COLLEAGUES



"With cutbacks in government funding, grassroots organizations like ours are looking for other sources of support," explains Brenda Jones, executive director of the Minority Health Coalition of Madison County. As one of 40 agency leaders to attend a Foundation-sponsored seminar on grant writing in July, Jones not only learned how to create effective grant proposals but also where to send them.

Agencies searching for financial backing often are surprised to learn who is most likely to support their missions, according to Bobbie Donahue, a faculty member at The Fund Raising School of Indiana University and leader of the local seminar. "Individuals contribute 75.6 percent of total giving in the U.S., followed by foundations at 11.6 percent," she says. Bequests and corporate sponsors round out the donor list. Determining who might underwrite a project takes research; writing a proposal that sparks the donor's interest takes skill. Donahue's workshop addressed both requirements. "I hope participants took away an understanding of the process of proposal writing and the confidence that they can implement the process."

The two-day workshop, which usually costs \$750 per registrant, was offered free of charge by the Community Foundation and Lilly Endowment. Conducted at the Flagship Park location of Ivy Tech, it was "crammed with information," says Jones. It included written exercises and opportunities to evaluate grant proposals and discuss why some are accepted and others are rejected.

An unexpected bonus of the seminar was the camaraderie that resulted from working side by side with community colleagues with similar interests. "I didn't realize that I would meet people from agencies that I don't usually interact with," says Jones. "At the end of the session we received a list with everyone's names and organizations. Now I have a contact sheet of new resources. That in itself was valuable."


