The only encyclopedic art museum in South-Central Texas, SAMA houses more than 30,000 works spanning six continents and 5,000 years of human creative expression. The collection includes the foremost assemblage of art of the Ancient Mediterranean in the state, with important ancient Roman, Egyptian, Greek, Etruscan, and Near Eastern objects; the largest concentration of Asian art in Texas, with a particular strength in Chinese ceramics; and an unparalleled collection of Latin American art, with ~10,000 works covering pre-1500 Indigenous cultures, Colonial, and modern and contemporary-notably, SAMA opened the first center devoted to Latin American art in the U.S. American, contemporary, photography, African, Islamic, and Aboriginal Australian art are also well represented at the Museum. SAMA acquired 177 artworks in 2024, strengthening its global-facing collection and influence. Each year, the Museum presents temporary exhibitions, longer-range focus presentations, collection-based installations, and ~500 programs to meet the needs of its ever-growing audience.

SAMA's 2024 exhibitions included: The Age of Armor: Treasures from the Higgins Armory Collection at the Worcester Art Museum, highlighting arms and armor in the golden age from the late Middle Ages to the Renaissance; Goddess Triptych Reunited, which centered three paintings by the late San Antonio-based artist Ángel Rodríguez-Díaz along with works from the Museum's Ancient Mediterranean collection, accentuating the feminine form across time, culture, and geography; Lovers & Fighters: Prints by Latino Artists in the SAMA Collection, exploring love, power, and struggle, and the significance of printmaking in Latino art history; Amalia Mesa-Bains: Archaeology of Memory, the first retrospective of the influential Chicana artist and cultural critic, featuring over 40 works in a range of media in a celebration of Mesa-Bains's important contributions to the field of contemporary art; and The World of Irreversible Change from international art collective teamLab making its US debut at SAMA, with the large participatory digital work presenting a birds-eye view of a virtual ancient city and its inhabitants and changing in real-time with the actions of viewers, the weather, and the time of day of its location.

SAMA creates and delivers meaningful interpretive programs that connect people to art, ideas, and each other through a dynamic exhibition calendar, comprehensive global collection, and other mission-driven offerings. With a variety of year-round initiatives for adult, family, children, university/college, and other audiences, the ~500 engagements carried out in 2024 included: a suite of docent-led tours for preK-12, collegiate, and adult audiences, including a new "off the wall" series offering fresh takes on the Museum's permanent collection; artist talks; artmaking experiences; lectures and panel discussions; music, dance, theatre, and other cultural performances; educator workshops; film screenings; a Kids' Studio early childhood learning program; immersive Family Days and other intergenerational programs; ReCollections, a memory initiative for people experiencing Alzheimer's and dementia, as well as their families and caregivers; and Haven for Hope hands-on art workshops for women and children experiencing homelessness. All SAMA programming is designed to motivate discovery, learning, creativity, reflection, and exchange through the lens of art.

Schedule D, Part III, Line 1 - In conformity with industry practice, museum collections items purchased or donated are not recorded as assets in the accompanying Statement of Financial Position. Even though not reflected, the Museum's collections represent one of its most valuable assets. Purchases of collection items are reported as decreases in unrestricted net assets or as decreases in temporary restricted net assets if the assets used to purchase the items were restricted by donors. It is the Museum's policy not to sell collection items. Any proceeds from deaccessions or insurance recoveries are reflected as increases in the appropriate net asset classes. The Museum employs full-time employees to manage the stewardship of the collections items in accordance with the collection and acquisition policy and under the direction of the executive director and board of directors. Each item is numbered and catalogued in a continuous inventory tracking system.

Schedule D, Part III, Line 4 - The Museum's collection is encyclopedic in that it spans time frames from antiquities to modern art, and includes works from a variety of cultures and countries of origin. It is comprised of statues, paintings, works in ceramics and other media.

Schedule D, Part V, Line 4 - Each year the Board traditionally allows the museum to draw 4.5% of the endowment. Draws may be spent according to the restrictions placed by the donor on those funds, those generally being support of the museum operations, costs of exhibitions and the cost of acquisition of art. Unspent portions of the 4.5% funds can be carried forward to subsequent years of expenditure. In unusual circumstances, the Board has authorized additional amounts to be drawn from the Endowment.

	<p>In 2024, on-site visitation was ~148,000, with many more visitors engaging in artworks and programming virtually. Based on annual Museum data, 44% of visitors to SAMA reside in San Antonio, Bexar County, and surrounding counties; approximately 40% are from elsewhere in Texas; and 19% are from outside the state. Approximately 48% of Museum visitors self-identify as Hispanic/Latino or Indigenous, 35% as Caucasian, and 16% as African American, Asian, and other. Eight percent (8%) identify as military with increases each year. Data from recent exhibitions indicate that approximately one-third of Museum visitors have household incomes less than \$50,000 and lack a college education. While attracting all age groups, SAMA draws most strongly from the 35-54 age group, including family households with children. The Museum is open Tuesday-Sunday from 10 am-5pm, except Tuesday and Friday when it remains open until 7 pm. In line with SAMA's 'access for all' mission, Bexar County residents receive free general admission during weekly Free Hours on Tuesdays 4-7pm and Sundays 10am-12pm. Children aged 12 and under always receive free admission. Free admission opportunities are integral to the Museum's charge to reach and engage all communities in Greater San Antonio, particularly those overlooked and under-resourced. To this end, SAMA also participates in two nationwide cultural admission programs for targeted individuals and families: Museums for All and Blue Star Museums.
